

NCCC-DUNTOV PERFORMANCE AWARD

I. WHAT IS THE NCCC-DUNTOV PERFORMANCE AWARD?

The NCCC-Duntov Performance Award recognizes the NCCC club that, in the determination of the Award Committee, demonstrates outstanding performance in achieving the purposes and ideals of the National Council of Corvette Clubs.

II. WHO IS ELIGIBLE TO RECEIVE THE AWARD?

Any NCCC club in good standings is eligible, provided they meet the criteria described in Article VI. No club, however, shall be eligible to receive the award in consecutive years.

III. WHEN WILL THE AWARD BE PRESENTED?

The award will be presented at the NCCC Convention, based on all criteria met by a qualified club during the prior year.

IV. HOW IS THE RECIPIENT CLUB SELECTED?

The NCCC Duntov Performance Award originates from the NCCC Membership Committee. The award selection committee shall consist of three (3) members from the Membership Committee. The members of the selection committee shall be appointed by the NCCC VP of Membership as needed. The Region Membership Director from a region under consideration for the award will not be permitted to serve on the selection committee.

Clubs shall be evaluated by the selection committee, based on applications and documentation received from eligible clubs given to VP of Membership in a sealed envelope no later than the beginning of the NCCC Membership committee meeting of the second scheduled NCCC Governor's meeting of the current year. The selection committee shall complete its evaluation and present the award at the NCCC National Convention.

V. WHAT IS THE FORM OF THE AWARD?

The NCCC-Duntov Performance Award shall be a high quality award of glass or high quality acrylic that reflects the visionary spirit of Zora A. Duntov. To the extent practical, the form and style of the award shall remain constant from year to year. The cost of the award shall not exceed three hundred fifty (\$350) per year, paid from the NCCC Membership Committee budget.

VI. WHAT ARE THE MINIMUM QUALIFICATIONS FOR A CLUB TO BE ELIGIBLE FOR THE AWARD?

A. MEMBERSHIP REQUIREMENTS

(Documentation Required: Club Roster, Printouts, and 51% sheets)

One hundred percent (100%) NCCC Membership by local club members (from 51% sheet) during the applicable year.
Minimum ninety percent (90%) renewal of club members from the previous year.
[Fifteen (15) Points Maximum]

B. NATIONAL COUNCIL INVOLVEMENT

(Documentation Required: Regional Minutes)

One hundred percent (100%) warm body representation at all
Regional meetings during the applicable year
[Five (5) Points Maximum]

(Documentation Required: NCCC Secretary Report)

One hundred percent (100%) warm body representation at all
NCCC Governor's Meetings during the applicable year.
[Ten (10) Points Maximum]

(Documentation Required: Print out from Convention Chairperson)

Attendance at the NCCC Convention during the applicable year by at least fifteen percent (15%) of the listed membership of the club. (Use first printout of applicable year to determine eligibility for this criteria.)
[Ten (10) Points Maximum]

C. COMPETITION

(Documentation Required: Signed Documentation of Final Point Standings Report from the VP of Competition)

Club must have finished in the top Fifteen percent (15%) nationally of clubs in the NCCC Competition Sanction Program during the applicable year.

(Documentation Required: Completed Event Result Sheets)

Club must have utilized all of its available sanctions hosting events during the applicable year.
[Ten (10) Points Maximum]

D. CHARITY

(Documentation Required: Copies of canceled checks)

Must provide evidence of a minimum of Seven hundred fifty dollars (\$750.00) in contributions to the NCCC Charity Committee or other qualified charitable organizations during the applicable year.

(Documentation Required: Thank You Letters, Flyers, Newspaper Articles, etc)

Must provide evidence of ongoing people involvement, other than financial contributions, with one or more charitable organizations during the applicable year.
[Twenty-five (25) Points Maximum]

E. OTHER

(Documentation Required: Narrative-what makes your club special)

Other notable actions, accomplishments, or leadership by the club Benefiting NCCC, the community, or the Corvette hobby that bring honor to the National Council of Corvette Clubs and the spirit of Zora A. Duntov.
[Twenty-five (25) Points Maximum]

VII. WHEN TO ENTER

Anytime after current year renewals and no later than the beginning of the NCCC Membership committee meeting of second scheduled NCCC Governor meeting of the current year. All entries must be received by the VP of Membership before the above listed date and time, in a sealed envelope with (One [1] Copy only) of all required documentation listed in section VI above. There will be no exceptions for missing documents or late submission.

POINT SYSTEM BONUS POINTS

Growth Bonus

0% - 4% = 0 point
5% - 9% = 0.5 point
10% - 14% = 1.0 points
15% - 30% = 1.5 points
31% and greater = 2.0 points

Renew Points

90% - 94% = 0 point
95% - 99% = 0.5 point
100% - 104% = 1.0 point
105% - 109% = 1.5 points
110% and greater = 2.0 points
