From the east or west on I-80/I-90/Indiana Toll Road take the US-31 Byp exit, EXIT 72

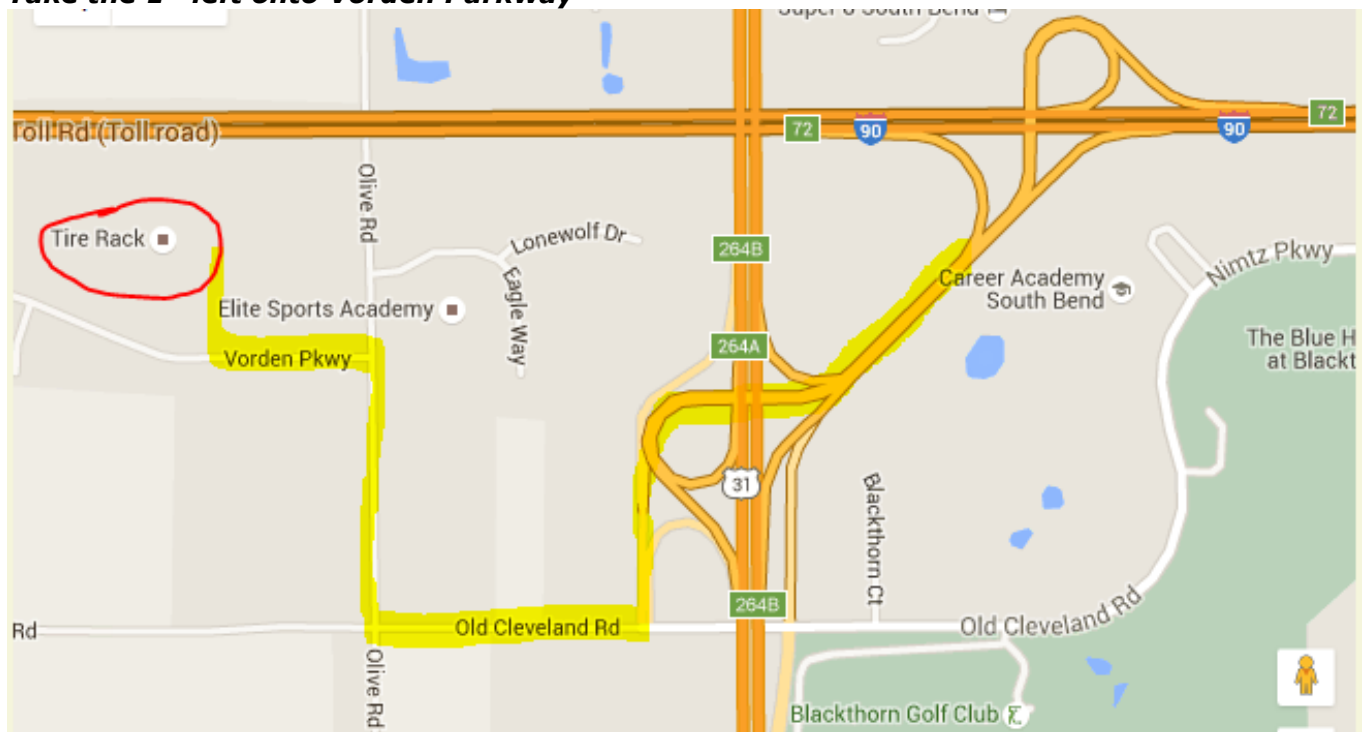
Keep left to take the US-31 S ramp toward South Bend/Plymouth (then .25 miles)
